Take US 101 North. Take the Prado Road exit and turn right. First driveway on the Right to 25 Prado Road, San Luis Obispo.

***From all points North of San Luis Obispo***

Take the Madonna Road/ CA-227 exit, stay on the right side go 0.2 mile. Turn right on Madonna Road. Go 0.3 mile over the freeway overpass, stay on right side and turn right on South Higuera St. Stay in the right lane, go 0.3 mile. Turn right on Elks Lane, go 0.5 mile. Turn left on Prado Rd. The first right driveway is the Corporation Yard, 25 Prado
